

With your generous support, our two school-based programs – The Character Effect™ and Beyond the Classroom™ – are seeing results, including improving children’s behavior and academic performance; reducing teachers’ stress, strengthening their classroom management skills; increasing parent involvement, and reducing family barriers to success.

For 675 families who received Parent Coaching in 11 pediatric offices that are participating in Parent Connex™.

For 53 foster care children who were reunified with their birth parents, for 27 children who were adopted, and for all 189 children who lived in a loving Beech Acres-supported Foster home.

The need for loving foster parents grows exponentially with the increased violence in families and substance abuse. Once a family heals, the ultimate goal is to return the child to their birth parents. When reunification is not possible often times the foster family caring for the child adopts.

With the generous support of bi3, Mental Health Recovery Services of Warren and Clinton Counties, and the United Way parents are finding new solutions to the challenges they face at various stages in their child’s development. Early results show increased parental confidence, role satisfaction, and improved child/parent relationships.

For 130 grandparents and other caring relatives who suddenly find themselves parenting their grandchildren and other relatives.




